

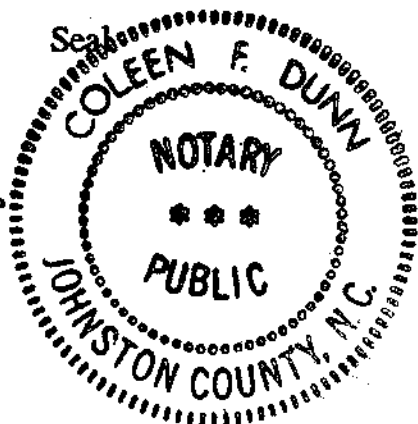

The North Carolina Campaign Reporting Office, on April 24, received a copy of the Monthly Report for DRIVE - Democrat, Republican, Independent Voter Education (PAC). This Report lists a contribution of \$1,000, on March 24, 1995, to the Elaine Marshall Campaign for NC Senate, District 15.

Before March 14, 1995, the Democratic, Republican, Independent Voter Education (PAC) was a Federal PAC registered with the Campaign Reporting Office. On this date, the Office received a letter from Mr. Christopher L. Scott, President of the North Carolina State AFL-CIO, stating DRIVE would no longer engage in campaign activities in North Carolina "State" elections; thus, our computer records indicate the Federal PAC is 'Closed'. Therefore, acceptance of the contribution places both the Committee and the Campaign in violation of G.S. 163-278.16(a)(1). The State Board of Elections must report apparent violations to the local prosecuting authority.

This is official notice that unless the contribution is returned and a copy of the refund check and letter making the refund are received by this office, or DRIVE - Democrat Republican Independent Voter Education Political Committee reregisters, we shall have no alternative except to report the apparent violation to the local district attorney.

A deadline of 5:00 p.m. on Friday, May 5, 1995 for a response is set.
