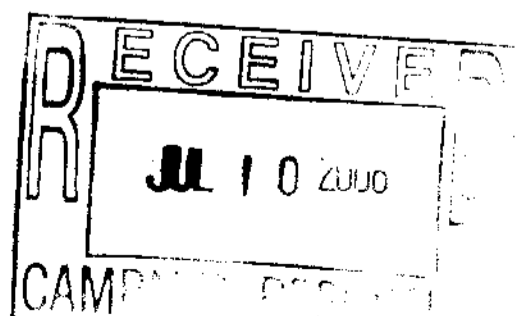
Dear Ms. Strach:

I write in behalf of the Citizens for Higher Education PAC in my capacity as assistant treasurer. I write to note one minor matter with respect to the report, which we believe to be a function of the operation of the online software.

With respect to our contributor, Charles E. Hamner Jr., whose contribution is on page 9 of the current report, section (e) for Mr. Hamner reports an election sum to date of \$7,500. Mr. Hamner has, since the November 7, 2006 general election only a total of \$5,000, which sum is made up of a contribution dated November 26, 2007 and June 21, 2008 each in amounts of \$2,500.

Mr. Hamner did make a contribution on November 7, 2006, which was reported as having been made on that date and which was the subject of a 48 hour notice on that date. That contribution was designated for the 2006 general election as we would believe it should have been, but it is apparently being picked up by the software in the total set forth in section (e) of the report.

I don't think causes any further issues, but we believe you should be made aware if this matter.
