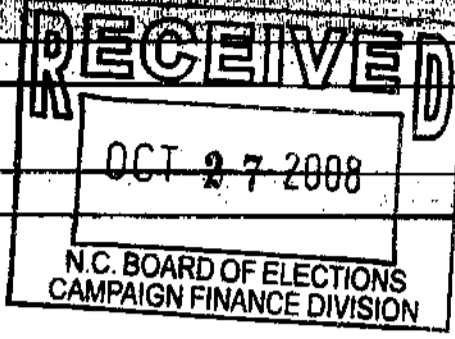


48-Hour Notice
